I fully understand that horses are unpredictable and as a result

- _____ I am the Parent and/or Legal Guardian of the Child Participant to help volunteer or help clean property named above and am executing this form on behalf of myself or the Child Participant volunteer to visit property with an accompanied legal guardian in my capacity as parent and/or guardian and with the intent that this form be binding on myself and my child or accompanied Child with a letter of consent by their parent/Legal guardian.

- _____ I understand there are inherent DANGERS, HAZARDS and RISKS, (collectively "RISKS") associated with Horses and injuries resulting from these "RISKS" are a common occurrence. I acknowledge that I am familiar with the RISKS and in spite of the RISKS I have voluntarily and freely retained that I will not hold responsible the **Landowners, Marcia and James Wagner, Mary Howe and Family, Volunteers and SonFlower Stables and Board of Directors, and their families, and or any farm and or Practitioner working alongside Mary Howe** on leased premises with the specific knowledge that I am potentially subjecting myself, or my child if applicable) to serious physical injury or death.

- _____ I acknowledge that the inherent "RISKS" of working around Horses are within those DANGEROUS conditions which are an integral part of working with Horses, including but not limited to: The propensity of any horse to behave in ways that might result in injury, harm or death to persons on or around them and to potentially collide with, bite or kick, or step on other animals, people, or objects The unpredictability of an Horse or Goat reaction to such things as sounds, sudden movement, tremors, vibrations, unfamiliar objects, persons or other animals and hazards such as subsurface objects.

- _____ I understand the potential for other participant (s) to act in an intentional or negligent manner that might contribute to injury to themselves or me or my child, such as failing to act within their ability or to maintain control over a Horse. I hereby release and hold harmless the Landowner, Marcia and James Wagner, Mary Howe and family, Volunteers and SonFlower Stables from any and all claims, demands, actions and/or claims that I possess in law, equity or statute as a result of any loss, damage, personal injury or death that I, or my child if applicable, may suffer due to any action or negligence by another participant.
